Update on Housing Sub-committee meeting with Dracut Selectmen.

Members of the Dracut Housing Authority Housing Sub Committee in conjunction with the Selectmen Housing Sub Committee met on August 19, 2013 at 971 Mammoth Road. F. Russell Taylor, Brian Bond, Mary T. Karabatsos, Robert Cox, Joseph Dirocco were in attendance to discuss the development of the Richardson property. Commissioner Brian Bond thought it would be wise to reach out to both Selectmen and the community. Mr. Bond thought by getting everyone involved in the discussion for additional housing would make the process much more productive. Brian Bond informed the board that the housing authority will be asking CPC for three million dollars in seed money to move the project along. The sub committees will continue to meet to iron out all the various issues pertaining to the Richardson property. Both housing committee's agreed to bring the information back to their selective boards and to continue to have joint meetings to discuss future funding to keep the project moving forward.

Update on the demolition of house at 1530 Bridge Street.

The Executive Director has contacted the company to get a price on the demolition of the house. The company will give an estimate within the week. The Executive Director also contacted ACT which is a company to check to see if there are any hazardous materials or asbestos in the house that would have to be removed. Commissioner Ken Cunha informed the board that the Historical Commission has to give approval to all buildings being demolished in the town. The cost of the demolition to the house will be covered by the CPC.
